#### (2) Reason for the change

Since becoming President and CEO of the Company in 2008, Kazuhide Kamitani has devoted himself to expanding the businesses of the Company and its group of companies. He shifted the Company to a bank holding company structure in April 2013 to promote the creation of a new business model that unifies the retail and financial services businesses.

With management strategy now decided under the bank holding company structure, the Company has decided to inaugurate a new system with the change in representative director.
