The Group's Overseas Subsidiary Receives International ESG Award

— Hong Kong Subsidiary Receives Award in Sustainable Finance Category
and First-Time Selection in the S&P Global Yearbook —

AEON Credit Service (Asia) Company Limited (Managing Director: Wei Aiguo, hereinafter ACSA), a Hong Kong subsidiary of AEON Financial Service Co., Ltd. (President and CEO: Tomoharu Fukayama), has received an international award in recognition of its efforts in environmental, social, and governance (ESG) initiatives.

1. Award in the Sustainable Finance Field

ACSA received the "Best Sustainability-Linked Loan – NBFI in Hong Kong" award at "The Asset Triple A Sustainable Finance Awards 2026," hosted by The Asset, one of Asia's leading financial magazines. This award recognizes ACSA's sustainability-linked loans totaling HK\$300 million (*1) implemented in 2025, and acknowledges its pioneering efforts in linking the achievement of ESG goals with financial terms.

2. First-Time Selection for the S&P Global Sustainability Yearbook

In addition, ACSA has been selected for the first time for the "S&P Global Sustainability Yearbook 2026 (China Edition)," published by S&P Global, a global ESG rating agency.

This yearbook is based on S&P Global's Corporate Sustainability Assessment (CSA), which evaluates companies worldwide. Only about 190 companies are selected from over 1,600 companies evaluated, and ACSA was evaluated as being in the top 15% of sustainability companies in its industry.



Furthermore, AEON Credit Service (M) Berhad, a local subsidiary in Malaysia, has also received recognition for its efforts in various Asian countries, including winning the "Best Social Loan - Consumer Finance" award at "The Asset Triple A Digital Finance Awards 2026," hosted by The Asset.
